1.0 Overview of the Expression of Interest

Kimisitu Sacco Society Ltd wishes to invite Expression of Interest from bidders for the Provision of ERP System Upgrade, Supply, Configuration, Integration, Testing, Training, Migration and Commissioning. The Sacco plans to implement a platform that will empower business users to create quick visualized reports and Dashboards. With the help of new generation tools, Kimisitu Sacco Society Ltd wishes to generate interactive reports and visualizations in an agile manner.

2.0 Background

Kimisitu Sacco Society Selected Ms Dynamics Nav ERP 2016 as the solution to implement and has since been in use for approximately 5 Years. The modules identified for implementation included General Ledger, accounts Receivable, Accounts Payable, Procurement, Human Resource Leave Management, Payroll and BOSA.

The Sacco has however not realized the full benefit of the ERP since some of the processes were still being done manually.

3. Purpose

The purpose of this document is to solicit proposals for the supply and implementation of Dynamics 365 Business Central for Kimisitu Co-operative Savings and Credit Society Limited.

4.0 Objective

The objective is to select suitable contractor(s) and establish a contract with successful bidder(s) for upgrading the current version to Dynamics 365 Business Central. The proposed Sacco Management Information System should be scalable enough to accommodate the current and envisioned future growth of the SACCO. For this reason, prospective vendors are requested to propose the best and most cost-effective solution to meet Kimisitu Sacco requirements, while ensuring a high level of service

5.0 Scope of Work

The Scope of work entails and not limited to implementation of the following:

- Supply, Installation / Implementation, Customization, Training, Testing, data migration and Commissioning of Dynamics 365 Business Central (ERP) for all Modules and functionalities required.
- 2) Supply, Installation and commissioning of genuine licensed ERP Database System and related software utilities and add-ons
- Supply of Dynamics 365 Business Central user Licenses for Database system and ERP Systems
- 4) Project Implementation Services
 - i. Requirement Analysis
 - ii. Implementation and customization of various modules and reports
 - iii. User Acceptance Testing (UAT)
 - iv. Integrations to currently running support systems e.g. CRM, Call Centre, BI, Mobile Banking, ATM, EDR etc.
