1.1 Definitions

Throughout this document, the following expressions shall have the given meaning unless the context requires otherwise:

'G4S'	means the applicable operating company within the G4S group of companies responsible for each premise
'Supplier'	means the person, firm, company or entity that submit qualifying tenders
'Proposal'	means the response to this TENDER made by the Contractor or Suppliers to G4S in accordance with Part 3 of the TENDER
'Requirement'	means the supply to be made by the Contractor to G4S in accordance with Part 3 of the TENDER
TENDER'	means this 'Request for Proposal

1.2 Background

G4S is an Allied Universal® Company, the world's leading global, integrated security company specialising in the delivery of security and related services in 90 countries globally with 800,000 employees.

As part of the administration services it renders, G4S is required, from time to time and/or as and when a need arises, to procure services or products from third parties on behalf of one or more of its associates.

2. GENERAL CONDITIONS

- **2.1** The acceptance of any bid is subject to the terms and conditions as set out in this Tender.
- **2.1.1** This Tender contains Confidential Information proprietary to G4S. The review of any Proposal is subject to the Confidentiality and Non-disclosure Agreement ("NDA") set out in Annexure A hereto. Any bid that is not accompanied by a signed NDA will be disregarded.
- **2.1.2** Press releases or any other form of public disclosure relating to this TENDER, or to the award resulting from the TENDER, shall only be made on prior written approval from G4S and G4S shall be entitled to review the contents of such intended press releases.
- **2.1.3** The Bidder shall not disclose the TENDER process or any matter relating thereto to any third party without the prior written consent of G4S.
- **2.1.4** The submitted Proposal shall be valid for one hundred eighty (180) days from the date of submission of the Proposal to G4S or as agreed between parties based on expected implementation.
- **2.1.5** All Annexures must be completed in full and all information requested must be provided. Failure to complete any Annexure or to provide any information shall be deemed to be as though the Bidder does not have the capability or information requested.
- **2.1.6** The Bidder shall be liable for all costs incurred in the submission of a bid.
- **2.1.7** All Proposals and documents submitted by the Bidder to G4S shall become the property of G4S and will not be returned to the Bidder.
- **2.1.8** The receipt of a Proposal by G4S does not obligate G4S to enter into a contract or any business activity with the Bidder.
- **2.1.9** G4S shall at its sole discretion determine the manner in which to proceed with this TENDER including but not limited to abandoning this TENDER. G4S reserves the right to reject a Proposal or accept a Proposal in full or partially. The decision of G4S shall be final and binding and no correspondence will be entered into with any Bidder following the acceptance or rejection of a Proposal.
- **2.1.10** G4S reserves the right to waive or not waive formalities or irregularities in Proposals, and to accept or further negotiate cost, terms, or conditions of any Proposal determined

to be in the best interests of G4S.

- **2.1.11** G4S reserves the right to disqualify a Bidder in the event the Bidder submits a Proposal after the TENDER submission deadline as set out in clause 7.
- **2.1.12** G4S reserves the right to cancel this TENDER at any time prior to the execution of a written contract without any liability to G4S.
- **2.1.13** Responses to this TENDER will be the primary basis from which a decision will be made. However, G4S may require additional information and/or a presentation after submission of a Proposal. The Bidder agrees that the request for additional information by G4S does not create any expectation of the awarding of any business to it.
- **2.1.14** G4S shall have the right to use any or all ideas presented in any Proposal received in response to this TENDER unless the responding Bidder presents a statement of objection in the Proposal. In no event shall such objection be considered as valid with respect to the use of such ideas that are not the proprietary information of the Bidder and so designated in the Proposal.
- **2.1.15** Prospective Bidders shall obtain no advantage from any errors or omissions in the TENDER documents. In the event that Bidder discovers any errors or omissions, then Bidder shall notify the G4S.

3. THE SCOPE AND OBJECTIVES OF THE TENDER

- 3.1 This TENDER is for the benefit of G4S.
- 3.2 Where applicable, RACI matrix should be included to indicate responsibilities at the TENDER stage.
- 3.3 Business Continuity/Disaster recovery plans of the bidding company must be included in the TENDER response. Reference must be made to infrastructure and staff members/key personnel, as well as relevant skills/CV of team members that are included on the delivery team as per the RACI matrix.
- 3.4 Bidders must provide an overview of their internal risk management methodology.
- 3.5 The Proposal must address the improvement of the TENDER requirement clearly differentiating between current solution offering and customization/development capabilities/pipeline for the provision of an effective and efficient overall solution that would provide clear distinction and competitive advantage for G4S.
- 3.6 All Bidders must provide evidence of their compliance to the Health and Safety Act and any other applicable regulatory requirements.
- 3.7 Bidders must provide G4S with a copy of their current year tax certificate and VAT details.
- 3.8 Applicable indemnity insurance details should also be included where required i.e., contractors all risks, public indemnity, professional indemnity cover etc.

- 3.9 It is not the intention of G4S to limit the Bidder to a specific solution. The Bidder is required to be innovative and forward thinking in their Proposal and should be guided by the principle that G4S looks at building a strong mutually beneficial strategic partnership and platform with their selected Bidders based on their ability to maximise value and create a strong competitive advantage for G4S. The nature of the proposed solution will play a critical role in the shortlisting of the successful Bidder(s) during a formalised TENDER and/or TENDER process.
- 3.10 G4S has supplied the Bidders with sufficient information to enable the Bidder to produce a comprehensive and innovative response to this TENDER. However, should the Bidder require additional information, the Bidder may contact the G4S Project representative, details of which are set out in Section II. Enquiries should make specific reference to the applicable section and page numbers within the TENDER. Enquiries must be stated clearly. G4S shall, at its sole discretion, disclose information to enquiries.
- 3.11 The Bidder shall not or attempt to circumvent the TENDER process by virtue of contacts within G4S.
- 3.12 Failure to adhere to point 3.12 or any specific related bidding requirement defined in this document may result in the Bidder being excluded from the TENDER process and any existing or future business arrangement.
- 3.13 The successful Bidder will not be permitted to sub-contract the whole or any portion of their proposed solution without the prior express, written consent of G4S.
- 3.14 The successful Bidder will be held responsible for its own employees' health and safety. G4S will not be liable for any health and safety aspects in respect of the successful Bidder and his/her employees. The successful Bidder will be required to sign a Section 37(2) Agreement in terms of the Occupational Health and Safety Act ("the Act") and may be required to comply with G4S Health and Safety Regulations (refer to Annexure E).

4. THE RESPONSE TO THE TENDER

- 4.1 It is necessary that the Bidders submit as much information as possible to provide comprehensive and innovative Proposals. G4S-has appointed SRM eProcurement to manage this bid. All bids shall therefore be submitted through <u>www.srmhub.com</u>. All Responses shall be submitted through SRM eprocurement portal.
- 4.2 Without limiting the contents of Proposals, the Proposals should include *at a minimum* all the information requested in the Annexures hereto upon request.
- 4.3 Should the Bidders wish to provide additional information not requested in the TENDER, which the Bidders believe will add value to the objectives of G4S Group in respect of this TENDER, the Bidders should include such information under additional information in Annexure D with no liability or recourse against G4S.

4.4 Proposal Format and Submission requirements:

- **4.4.1** Suppliers must submit the response to the through SRM eprocurement portal before the deadline stipulated.
- **4.4.2** The Bidders should make sure that they respond to all the mandatory statements or electronic questions in the portal. Applicant shall not be able to respond to the bid if the skip mandatory questions.
- **4.4.3** If the Bidders have no response to a statement or question, the item to which the Bidder has no response should be noted to that effect. The Bidders may indicate why they are not in a position to respond to a specific statement or question.
- **4.4.4** Clarifications, questions, and Updates during this TENDER process:

No other company personnel or consultants are to be contacted unless directed to by the G4S contact(s). Answers to queries that seem to us of general interest will be distributed to all Suppliers as updates.

All communications must contain in the subject of the mail, the original subject of the original TENDER communication.

G4S may amend the TENDER documents by issuing update notices by way of formal variation and reserves the right to change or amend the TENDER Tender Schedule. Such updates should be considered thereafter as part of this TENDER.

Any documents received from any other source or in any other way are not to be considered as forming any part of this TENDER. G4S reserves the right to disqualify and reject proposals that do not comply with this requirement.

5. EVALUATION CRITERIA OF BIDS.

Criteria which bidders must meet in order to progress to the next round of evaluation. If a bidder does not meet any of the Essential Criteria, they will be excluded from the tender process immediately. These criteria are scored as 'Pass' / 'Fail'.

- **4.11.1** Bidder accepts G4S 'Terms and Conditions of Purchase' and that any business awarded to the bidder will be completed under the Terms and Conditions included in Section 2.
- **4.11.2** The Bidder and its staff (and any subcontractors used) agree to comply with SCI and the IAPG's policies listed in Section 2 of this pack throughout this tender process, and during any future works should the bidder be awarded a contract.
- **4.11.3** The bidder confirms they are not a prohibited party under applicable sanctions laws or anti-terrorism laws or provide goods under sanction by the United States of America or the European Union and accepts that SCI will undertake independent checks to validate this.
- **4.11.4** Legal establishment for a minimum of five years: From Registrar of Joint Stock Companies and Firms (RJSC), Kenya or equivalent authorities.

- **4.11.5** The Bidder confirms it is fully qualified, licensed and registered to trade with G4S (including compliance with all relevant local Country legislation).
- **4.11.6** This includes the Bidder submitting the following requirements (where applicable):
 - Legitimate business address
 - Tax registration number & certificate
 - Business registration certificate
 - Trading licence
- **4.11.7** Minimum 5 years of overall experience for providing Vehicle Repair & Maintenance Service to renowned companies.
- **4.11.8** Required to serve 10 corporate customers in the last 5 years, a reputed organisation (Security company/Logistics /Financial Institution).
- **4.11.9** Audited Financial Statements for the last 2 financial years of the organisation or bank statement of last year is mandatory (other than limited company)
- **4.11.10** The Committee will evaluate the Bids based on, among others, the following Criteria:
 - Spare parts Management System
 - Management experience and qualifications of senior management to be involved in the implementation of the Bid.
 - Track record and competitiveness.
 - Investment in technology
 - Quality
 - Sustainability
 - Capability, compliance, and overall value for money.
 - G4S reserves the right to request additional information to support further evaluation of the Proposals.

4.13 TECHNICAL CRITERIA (50%)

Criteria used to evaluate the bidders ability, skill and experience in relation to the requirements. Bids will be evaluated against the same pre-agreed Criteria.

4.14 COMMERCIAL CRITERIA (50%)

Criteria used to evaluate the commercial competitiveness of a bid. Bids will be evaluated against the same pre-agreed Criteria. See supplier response template

5.1 Negotiation of an agreement.

G4S Group will negotiate an agreement with the selected Bidder. It is recorded that the receipt of a Proposal by G4S is subject to the condition that G4S accepts the Proposal and enters negotiations with the selected Bidder to formalise and enter into a formal written agreement to regulate the relationship between the parties. Therefore, G4S shall not be liable for any loss or damage suffered by the Bidder or any third party.

5.2 Alternative Proposals

Suppliers may submit additional alternative proposals should they feel it may offer G4S additional benefits whilst still complying with the Requirement. G4S reserves the right to accept or reject any proposed alternative either wholly or in part. No alteration shall be made in the Form of Proposal or in the Specification(s) and Schedules. The Tenderer must submit a Proposal which complies with the Specification(s) but may in addition submit an alternative Proposal embodying any variations which they wish to suggest. Full particulars of any alternatives and such variations shall be submitted on separate sheets.

5.3 Validity of Proposals

Proposals submitted in response to this TENDER are to remain valid for a minimum period of 365 days (year) from the date of Submission of any contract emanating from the successful award for this TENDER.

5.4 Withdrawal from the TENDER

Should the Supplier wish to withdraw at any time prior to the TENDER closing date this must be done in writing to the G4S contacts listed above.

5.5 Supplier to inform themselves / due diligence

G4S has taken all reasonable care to ensure that the TENDER is accurate, however G4S gives no representation or warranty as to the accuracy or sufficiency of the contained information and that all Suppliers will receive the same information.

Suppliers are required to inform themselves fully of all conditions, risks and other circumstances relating to the proposed contract prior to submitting a Proposal. Proposed prices shall be deemed to cover the cost of complying with all the conditions of the TENDER and of all things necessary for the due and proper performance and completion of the Requirement

5.6 Inconsistencies and omissions

Suppliers must promptly advise G4S in writing of any inconsistencies and omissions they discover in the TENDER.

5.7 Late Proposals

There will be no allowance made by G4S for any delays in transmission of the Proposal. Proposals received later than the stipulated closing date will be removed from consideration.

5.8 **Proposal acknowledgement**

By participating in this TENDER Suppliers are indicating their acceptance to be bound by conditions set out in this TENDER. Suppliers are to acknowledge this acceptance, and furnish details of their representative that will be the sole point of contact for all matters relating to the TENDER, in writing, to the Company prior to the proposal acknowledgement due date

Any Supplier choosing to not submit a Proposal is required to acknowledge this intent, in writing, to the Company and return all TENDER documentation (or delete if on email) to the Company prior to the proposal acknowledgement due date.

5. RESERVATION OF RIGHTS

In response to the TENDER Requirement set out in Annexure B, the Bidder is invited to submit a Proposal in respect of an operational and procedural solution together with performance and service standards that is the most cost effective, innovative, and efficient Product or Service to G4S.

6. TENDER PROCESS TIMELINES

- 6.1 Should G4S not be able to act within these stipulated time frames, G4S shall notify the Bidder setting out the new dates for the completion of the activity.
- 6.2 If the Bidder has not received any communication from G4S following the expiry of the Evaluation Process, the Proposal shall be deemed as being rejected by G4S.

- 7.2 Once the TENDER has been received by the Bidders, the Bidders shall not communicate with any employee of the G4S Group in respect of the TENDER, as set out in clause 1 above.
- 7.3 Bidders who breach the communication process set out in this TENDER may be disqualified from the bidding process.

8. FINAL SELECTION

8.1 It is recorded that notwithstanding any provision in this TENDER, G4S Group shall during the evaluation of the Bidders take into consideration different factors and the criteria set out in clause 5.5 shall only serve as guidelines in the evaluation process. Therefore, G4S Group shall be entitled to attach different weights to each criterion guided by the best interests of G4S Group at the time of evaluation. G4S Group is under no obligation to accept the lowest priced Bid.

- 8.2 G4S Group reserves the right to reject all the Bids, to depart from any terms and conditions or data contained within this TENDER, and to negotiate with one or more Bidders. Furthermore, G4S Group reserves the right to terminate negotiations with any Bidder at any time without incurring any liability.
- 8.3 G4S Group reserves the right to award a Bid or any part thereof at its sole discretion to any of the submitted Bids.
- 8.4 This Bid is specifically for the scope as defined in this document, no combined Bids shall be accepted or considered by G4S Group unless otherwise stated or at the request of G4S.
- 8.5 G4S will evaluate this tender on the basis of capability, compliance and overall value for money:
 - The best overall value for money suited to G4S requirements
 - Sustainability, contingency plans, and green initiatives.

9. CONFIDENTIALITY PROVISION

- 9.1 The Bidders will be requested, as the first step of the TENDER process, to sign confidentiality agreements and return them to G4S Group within the time frames set out in the TENDER Document. The confidentiality agreement will be part of the legal documents governing the relationship between the Parties. Should the Bidders wish that any information contained in the Bid remains confidential; the Bidders shall advise G4S Group accordingly in writing at the time of submitting the Bid. The Bidder shall mark any material it wishes to keep confidential accordingly. However, G4S Group may disclose such confidential information to its internal employees and/or external auditors and attorneys, consultants and advisors, or any other person in a confidential relationship with G4S Group and who is under a duty of confidentiality.
 - This TENDER is considered G4S Group proprietary confidential information. In responding to this TENDER, the Bidder agrees to keep confidential this TENDER and all information and materials which may be disclosed by G4S Group to Bidder's employees, agents, and or subcontractors in the conduct of business under this TENDER.

TENDER is a request for a Proposal and not an offer document; answers to it must not be construed as acceptance of an offer or imply the existence of a contract between the parties.

G4S Group reserves the right to supplement or amend any of the terms of this Request for Proposal or Contract or any of the documents contained or referred to therein at any time during the Proposal process. Some of the provisions have been left undrafted or drafted in outline only. Definitive drafting of most of these will follow in due course after discussions have been held with Bidders

11. Data Ownership and Intellectual Property

Each Bidder shall verify, in writing (where applicable), that:

- Bidder has the authority to grant G4S Group an unlimited, perpetual, royalty-free right and licence to use, disclose, copy, distribute, publish, or otherwise share such data with G4S Group' business affiliates, contractors, agents, and Bidders.
- The data proposed to be provided hereunder shall not constitute a violation of any confidentiality agreements or the Intellectual Property Rights of any third party.

For the purposes of this TENDER, "intellectual property rights" means, on a world-wide basis, any and all now known or hereafter known tangible and intangible (a) rights associated with works of authorship including, without limitation, copyrights, moral rights and maskworks, (b) trademark and trade name rights and similar rights, (c) trade secret rights, (d) patents, designs, algorithms and other industrial property rights, (e) all other intellectual and industrial property rights of every kind and nature and however designated, whether arising by operation of law, contract, licence or otherwise, and (f) all registrations, initial applications, renewals, extensions, continuations, divisions or reissues thereof now or hereafter made, existing, or in force (including any rights in any of the foregoing).

13.1 Background and context

G4S has a fleet of 638 (351 vehicles and 287 motorcycles) and is looking for suppliers who can provide spare parts as defined in Annexure A.

13.3 Other information

- Submission must include detailed specifications of the services/ product
- Proposal for above mentioned requirements with costs thereof

14. Pricing information

14.1 Prices To include all costs

- Submitted rates and prices are deemed to include all costs, insurances, taxes, fees, expenses, liabilities, obligations risk and other things necessary for the performance of the requirement. Any charge not stated in the Proposal as being additional, will not be allowed as a charge against any transaction under any resultant contract.
- We are looking to get proposals for both outright purchase and rental purchase of both models (i.e G4S Internal Solution and Customer focussed Solution).
- If a supplier has an advanced platform or AI system they should clearly indicate the pricing for base, intermediary and advanced system

14.2 Applicable VAT

Proposal rates and prices shall be exclusive of Value Added Tax.

14.3 Currency of proposed rates and prices

Unless otherwise indicated, all rates and prices submitted by Suppliers shall be in Kenyan Shillings (KES) **only**.

13.4 Rates and Prices

- Bidders are required to provide a comprehensive price schedule taking into account all resources and outputs to be achieved.
- G4S will not entertain any price adjustments for it assumes that the pricing document as supplied is complete and covers all costs associated with these services.
- All pricing assumptions excluded costs and estimated costs must be clearly documented.

14. Information to be provided in the TENDER Response

This Part details all the information Suppliers are required to provide to G4S. Submitted information will be used in the evaluation of the Proposals
